INSTRUCTIONS OF THE AUTHORS OF ADVANCES IN SCIENTIFIC AND APPLIED ACCOUNTING (ASAA)

CONDITIONS FOR SUBMISSION

s part of the submission process, authors are required to verify compliance of the submission concerning all items listed below. Submissions that do not conform to the standards will be returned to the authors.

Papers submitted to ASAA must be unpublished; that is, they have not been sent for publication in another journal. If paper is already published in annals of events and congresses, the name, place, and date of the event or congress must be indicated so that, if the article is accepted, this information is also published. Naturally, reviewers will not have access to this information.

Authors should not submit the paper to another journal, i.e., once submitted to the ASAA; otherwise authors should undertake to evaluate the outcome for the case not approved, refer to another journal.

The papers can be written in Portuguese, Spanish or English, with a minimum of 6,000 and a maximum of 9,000 words.

Papers will be published in up to three languages (Portuguese and English) or (Spanish and English). Papers submitted in Portuguese and Spanish will be translated into English. Papers submitted in English will be translated into Portuguese. The translation will take place after the review processes when the paper is accepted, and the authors agree to the changes made.

The paper must be submitted electronically through the ASAA website (http://asaaccounting. info/index.php/asaa/). After submission, authors will receive an automatic confirmation from ASAA.

For paper submission, the following editorial standards of ASAA should be observed:

- 1) Cover sheet in a separate file, with the following information:
- 1.1) Title of the paper in the language of the text and English;
- 1.2) Full name and title of the author(s), limited to 4 authors per paper;
- 1.3) Institution of the author(s):
- 1.4) Address, telefone number, and e-mail for contact.
- 2) Papers must contain:
- 2.1) the title without identification of the author(s);
- 2.2) an abstract (in the language of the text) with a minimum of 200 and a maximum of 250 words, separated into 4 sections, composed of the following elements: (i) Objective (s), (ii) Method, (iii) Results or Discussion and (iv) Contributions. The abstract should be followed by three to five keywords.
- 3) The paper pages should be properly numbered in the lower right corner, typed in Word for Windows text editor, on a single side of the sheet under the following conditions:
 - 3.1) A4 size paper (210 x 297 mm);
 - 3.2) Arial font, size 12;
 - 3.3) line spacing: 1.5;
 - 3.4) paragraph entry: 1.25;
 - 3.5) margins: upper 3cm, lower 2cm, left 3cm, right 2cm;
 - 3.6) illustrations and tables in ARIAL font, size 10;

- 3.7) citations and references must obey the current standards of the American Psychological Association (APA);
- 3.8) References should be listed at the end of the text according to the APA American Psychological Association, revised in alphabetical order in font 12, with single spacing and one blank line after each work.
